Re: Maine Department of Environmental Protection (the “Department”) Consolidated Petition for Release from Dam Ownership related to Silver Lake, Alamoosook Lake, and Toddy Pond, 38 M.R.S. §§ 901, et. seq. (the “Petition”)

Dear Ms. Paye:

In accordance with 38 M.R.S. § 902(4-A), Bucksport Mill LLC (“Bucksport Mill” or “Petitioner”) hereby provides this report on its consultation with prospective transferees in connection with the above-captioned Petition (the “Consultation Report”). This Consultation Report details the extensive consultation, correspondence, and document production that Petitioner has undertaken with those entities that, after the public meeting, expressed continued interest in conducting diligence towards a possible transfer. It also describes the status of negotiation with the prospective transferees it has located through the process.

Bucksport Mill is optimistic that it has located three counterparties that are interested in taking ownership of the Toddy Pond Dam, Alamoosook Lake Dam, and Silver Lake Dam, along with associated infrastructure (collectively the “Fresh Water System”).<sup>1</sup> As discussed below, while there are issues to resolve as part of the negotiated transfer process, including resolution of existing obligations and rights *vis á vis* the Fresh Water System, Petitioner is hopeful, given the status of ongoing discussions with the referenced counterparties, that continued negotiation will result in a transfer of the Fresh Water System to those parties who derive benefit from its existence, maintenance and upkeep.

In addition to the discussions with the identified potential counterparties, Bucksport Mill is currently in active discussions with Bucksport Generation and the Maine Water Company

regarding the rights and obligations they may have with respect to the Fresh Water System. The proposed parameters of the potential transactions have recently been shared with Bucksport Mill. Bucksport Mill is now able to, and has initiated, discussions regarding any consent that may be required before a transfer of the Fresh Water System can be finalized.

### **The Petition**

Bucksport Mill petitioned the Department for release from dam ownership on July 18, 2024. After submitting its initial petition, the Department followed up requesting additional information and requiring Petitioner resolve some notice deficiencies. Bucksport Mill complied with the Department's requests and submitted a revised Petition on October 18, 2024. The Department requested additional clarity and explanation of real estate rights, and Bucksport Mill provided a memorandum describing the encumbrances affecting the Fresh Water System, which concluded that "any owner of the dams will become and remain subject to appurtenant rights and obligations following the abandonment or transfer of Applicant's ownership...the materials provided establish appropriate title, right, or interest in the dams to support the MDEP initiating substantive review of the Petition."<sup>2 3</sup> The Department accepted Bucksport Mill's Petition as complete for processing on November 1, 2024.

### **The Notice**

Pursuant to 38 M.R.S. § 901(2), Bucksport Mill provided notice of its intent to petition the Department for release from dam ownership ("Notice"). Notice included the time, date and location of a Public Meeting hosted by Bucksport Mill to initiate the consultation process. Notice was published in the *Bangor Daily News* on October 19, 2024<sup>4</sup> and delivered to all statutory parties to consultation, as defined in 38 M.R.S. § 902(3). The names and addresses of all Notice parties were included with the Petition and is also appended to this Consultation Report as **Attachment A**. On April 30, 2025, Bucksport Mill provided a letter report documenting its compliance with the statutory notice requirements pursuant to 38 M.R.S. § 902(4) (The "Notice Report").

<sup>3</sup> Throughout the Petition, some parties have questioned whether Bucksport Mill has the requisite title, right, and interest ("TRI") to petition the Department for relief under the statute. Petitioner wants to be clear on this point: Bucksport Mill is the unrefuted owner of the dams, and any transfer restrictions, even if valid, do not preclude petitioning the Department for relief under the statute. The statute does not require the petitioner to own the dam free and clear of any restrictions or encumbrances. Indeed, the statute contemplates the Department issuing a Release Order to a petitioner, the impact of which may well be statutorily limited by existing property rights. *See* 38 M.R.S. § 905(2). Therefore, the resolution of all existing property rights cannot be a prerequisite to petitioning for relief under the statute. It is true that consummation of a proposed transfer may well require resolution (through consent or release) of any existing valid obligations prior to the actual transfer of ownership; a Release Order does not erase existing obligations, nor does it actually transfer ownership. Where, as here, Bucksport Mill owns the dams, has provided evidence of said ownership, and no evidence to the contrary has been provided, it has met its TRI obligations with respect to this Petition.

## The Public Meeting

In accordance with 38 M.R.S. § 902(1), the Notice described the statutory process for petitioning for release from dam ownership and explained that the Department may issue an order requiring a release of water if a new owner is not located. The Notice also explained that Petitioner would hold a public meeting on November 14, 2024 at the Maine Maritime Academy Center for Professional Mariner Development in Bucksport (the “Public Meeting”). As permitted by 38 M.R.S. § 902(1), Bucksport Mill met its obligation to consult with property owners by consulting with all Notice parties in attendance at the Public Meeting. In addition to the information contained in the Notice, Bucksport Mill verbally expressed the concepts required by statute at the Public Meeting.<sup>5</sup> Sign-in sheets with the names of those Notices parties that attended the Public Meeting are appended to this Consultation Report as **Attachment B**.

To ensure that each consulting party had a reasonable opportunity to assess its potential interest in taking ownership of the dams, Petitioner set up a publicly accessible webpage where it posted questions and answers (“Q&A”) raised during the Public Meeting as well as Q&A submitted to the webpage following the Public Meeting.<sup>6</sup> The webpage was updated on December 23, 2024 to include additional answers to questions received through December 2, 2024.

Following the Public Meeting, four municipalities (Orland, Surry, Penobscot, and Blue Hill) (collectively the “Towns”) and the Town of Bucksport (“Bucksport”) expressed interest in a potential transfer by seeking and obtaining municipal authorization to conduct diligence on the Fresh Water System.<sup>7</sup> No other consulting person or entity has expressed any interest in pursuing the possibility of owning some or all of the Fresh Water System.

## The Consultation Process

Contrary to assertions otherwise, Bucksport Mill reiterates, for the avoidance of doubt, that it has engaged in exhaustive and transparent consultation with interested parties, above and beyond any statutory requirement.<sup>8</sup> The substantial and voluminous record in this Petition (including four document productions totaling thousands of pages to assist the Towns and Bucksport in their evaluation) speaks for itself; Bucksport Mill has engaged in continuous consultation with interested parties and other stakeholders since filing this Petition, including:

June 27, 2025	Site Visit to the Fresh Water System with Bucksport Mill and its consulting engineer as well as representatives from the Towns, Bucksport, Bucksport Generation, and other interested stakeholders.
July 14, 2025	Document Production No. 4 to Bucksport Generation.
August 7, 2025	Response to Towns request for additional information following site visit.
August 26, 2025	Bucksport Mill letter response to Bucksport Generation requesting a general consent to a framework in which the Towns and Bucksport take ownership of the dams.
September 19, 2025	Bucksport Mill response to letters filed by Towns, Bucksport, Bucksport Generation, and Maine Water Company.
October 3, 2025	Telephone conferences with the Towns, Bucksport, Bucksport Generation, and Maine Water Company confirming the Towns and Bucksport are interested in pursuing dam ownership, potential parameters of such transactions, and discussing next steps. <sup>9</sup>

### **Prospective Transferees of the Fresh Water System**

Bucksport Mill is pleased to have located potential transferees of the Fresh Water System through the extensive consultation process. Bucksport Mill understands that the Towns are preparing for a November 4 town vote on the creation of two watershed districts, and those newly formed entities would be authorized to take ownership of the Toddy Pond and Alamoosook Lake dams. Bucksport Mill further understands that the Town of Bucksport is interested in pursuing ownership of the Silver Lake dam. While the details and mechanics of each respective transfer still need to be finalized, parties are now engaged in actively negotiating the terms of any transfers and Bucksport Mill respectfully requests that further action on this Petition be stayed pending the conclusion of



those negotiations. Bucksport Mill will report back to the Department in the unfortunate event that any of the negotiations fail, at which point it would request that the stay be lifted.

Bucksport Mill thanks the Department for its attention throughout this Petition process and looks forward to working collaboratively with each potential counterparty and associated stakeholders toward a transfer that considers and satisfies all valid rights and obligations relative to the Fresh Water System.
