Company Contact Information: In accordance with the Well Drillers and Pump Installers Rules, CMR Chapter 232, Section 204.5 effective January 1, 2012, no individual or company shall perform drilling or pump installation, repair or replacement without an appropriate and current license.

Per Title 32, Ch 69-C §4700-I: A person who holds a valid license as provided for in this section must be in the charge of a licensed well drilling company or pump installation company in order to actively practice well drilling or pump installation, repair or replacement.
