## Shellfish Harvesting Area Classification – Notification of Changes

August 22, 2025

**This notice is in effect until repealed or replaced.**

Ladies and Gentlemen:

Under the authority of 12 M.R.S.A. § 6172; the Commissioner has made the following changes to Growing Area ES, Thornton Pt (Cutler) to Lubec Neck (Lubec). This notice reclassifies a portion of the Lubec Channel (Lubec) from Restricted to Conditionally Approved due to water quality seasonally meeting approved standards. All existing pollution and biotoxin closures remain in effect.

The boundary descriptions of the area are as follows (struck text is being removed and underlined text is being added):

Prohibited: Effective immediately, because of pollution, it shall be unlawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops taken from the shores, flats and waters of the following Prohibited areas:

- P1. Bog Brook Cove (Trescott Twp): west of a line beginning at an unnamed prominent point approximately 400 yards northeast of the end of Rosebrooks Lane running north to an unnamed prominent point on the opposite shore.
- P2. Bog Brook Cove (Cutler): west of a line beginning at a unnamed prominent point at the end of Sebistose Lane running north to a point of land approximately 150 yards northeast of the end of Norse Pond Road.
- P3. Money Cove (Cutler): West of a line beginning at the easternmost tip of Marsh Point, then running northeast to the easternmost tip of Otter Point.

Restricted: Effective immediately, because of pollution, it shall be unlawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops (from aquaculture leases with an MOU only) from the shores, flats and waters of the following Restricted area without a special MDMR permit:

- ~~R1. Lubec Channel (Lubec): south and west of a line beginning at a red painted post on the southeast tip of West Quoddy Bar running southeast to the shore approximately 600 yards east of the intersection of West Quoddy Head Road and Carrying Place Cove Road.~~
- R21. Haycock Harbor (Trescott Twp): west of a line beginning at a red painted post located on the north shore of "The Pool" approximately 570 yards from the Route 191 bridge

crossing Wiggins Brook, then running southeast to a red painted post located on the south shore of "The Pool" approximately 550 yards from the Route 191 bridge crossing Wiggins Brook.

- R32. Little River (Cutler): west of a line beginning at the Fitzhenry Lobster Pound pier running north approximately 200 yards to a red painted post on the north shore of the Little River.

Conditionally Approved (Seasonal): Effective immediately, because of seasonal pollution, it shall be unlawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops (from aquaculture leases with an MOU only) from the shores, flats and waters of the following Conditionally Approved area(s) during the closed dates:

- CA1. Haycock Harbor (Trescott Twp): east of a line beginning at a red painted post located on the north shore of "The Pool" approximately 570 yards from the Route 191 bridge crossing Wiggins Brook, running southeast to a red painted post located on the south shore of "The Pool" approximately 550 yards from the Route 191 bridge crossing Wiggins Brook; AND west and north of a line beginning at the southwest tip of Batch Head running southwest to the end of the point on the north side of the mouth of Sandy Cove (closed July 1<sup>st</sup> through September 30<sup>th</sup>).
- CA2. Lubec Channel (Lubec): south and west of a line beginning at a red painted post on the southeast tip of West Quoddy Bar running, southeast to the shore approximately 600 yards east of the intersection of West Quoddy Head Road and Carrying Place Cove Road (closed July 1<sup>st</sup> through October 31<sup>st</sup>).


Approved: All other shores, flats and waters not described in the above sections are Approved and it is lawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops (from aquaculture leases with an MOU only) when in the open status.
