Shellfish Harvesting Area Classification – Notification of Changes

May 28, 2025

This notice is in effect until repealed or replaced.

Under the authority of 12 M.R.S.A. § 6172; the Commissioner has made the following changes to Growing Area WG, East Point (Biddeford) to Prouts Neck (Scarborough); this notice reclassifies the upper Nonesuch and one branch of the Scarborough River from Conditionally Approved to Restricted and adds a seasonal closure period in Back Bay, Biddeford Pool due to water quality no longer meeting the approved standard in the open status. All existing pollution and biotoxin closures remain in effect.

The boundary descriptions of the area are as follows (struck text is being removed and underlined text is being added):

Prohibited: Effective immediately, because of pollution, it shall be unlawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops taken from the shores, flats and waters of the following Prohibited areas:

- P1. Scarborough River (Scarborough): north of a line beginning at a red painted posted approximately 740 yards southeast of the Route 1 bridge in the Dunstan River running southeast to a red painted post on the opposite shore.
- P2. East Point (Biddeford) to Prouts Neck (Scarborough): south of a line beginning at the west tip of the jetty on the western shore of Prouts Neck (Scarborough) then running northwest to the end of Parcher Avenue off East Grand Avenue (Old Orchard Beach); AND southwest of a line beginning at the tip of Prouts Neck running southeast to the northeastern tip of Stratton Island; AND east of a line beginning at the southwestern tip of Stratton Island running southeast to buoy RW "WI"; then running southwest to the east tip of Wood Island (Biddeford); then running southwest to the east tip of East Point, Fletcher Neck (Biddeford), AND east of a line across the mouth of Biddeford Pool to the west end of Orcutt Blvd.

Restricted: Effective immediately, because of pollution, it shall be unlawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops (from aquaculture leases with an MOU only) from the shores, flats and waters of the following Restricted area without a special MDMR permit:

- R1. Nonesuch River (Scarborough): north of a line beginning at the end of Horseshoe Dr. running west to the opposite shore.
- R2. Scarborough River (Scarborough): north of a line beginning at a red painted post approximately 160 yards southwest of the end of Sandy Pt. Rd. running west to a red painted post on the opposite shore.

Conditionally Approved (WWTP & Seasonal): Effective immediately, because of proximity to a WWTP AND seasonal pollution, it shall be unlawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops (from aquaculture leases with an MOU only) from the shores, flats and waters of the following Conditionally Approved area(s) following a malfunction/CSO event at the Biddeford Pool Wastewater Treatment Plant. - CA1. Back Bay, Biddeford Pool (Biddeford): north of a line beginning at the unnamed point approximately 550 yards southeast of the end of Days Landing running northeast to the opposite shore at the intersection of Hills Beach Rd. and Surf Ave. (closed September 1st through October 31st).

Conditionally Approved (WWTP): Effective immediately, because of proximity to a WWTP, it shall be unlawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops (from aquaculture leases with an MOU only) from the shores, flats and waters of the following Conditionally Approved area(s) following a malfunction/CSO event at the Biddeford Pool Wastewater Treatment Plant. - CA2. Biddeford Pool (Biddeford): west of a line across the mouth of Biddeford Pool to the west end of Orcutt Blvd; AND south of a line beginning at the unnamed point approximately 550 yards southeast of the end of Days Landing running northeast to the opposite shore at the intersection of Hills Beach Rd. and Surf Ave.

Conditionally Approved (Rainfall): Effective immediately, because of intermittent pollution due to rainfall, it shall be unlawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops (from aquaculture leases with an MOU only) from the shores, flats and waters of the following Conditionally Approved area(s) when rainfall meets or exceeds 1" within a 24 hour period. - CA3. Nonesuch River (Scarborough): east of a line beginning at a red painted post at the end of Winnocks Neck Road running south to a red painted post on the opposite shore; AND south of a line beginning at the end of Horseshoe Dr. running west to the opposite shore.

- CA4. Scarborough River (Scarborough): west and north of a line beginning at the boat ramp at the end of Seaveys Landing Road running north-northeast to a red painted post at the center of a large unnamed island then continuing north-northeast to the opposite shore in line with the end of a large stand of trees; AND south of a line beginning at a red painted post approximately 740 yards southeast of the Route 1 bridge running southeast to a red painted post on the opposite shore; AND south of a line beginning at a red painted post approximately 160 yards southwest of the end of Sandy Pt. Rd. running west to a red painted post on the opposite shore.

Conditionally Approved (Rainfall & Seasonal): Effective immediately, because of intermittent pollution due to rainfall, it shall be unlawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops (from aquaculture leases with an MOU only) from the shores, flats and waters of the following Conditionally Approved area(s) when rainfall meets or exceeds 1" within a 24 hour

period OR during the closed dates. For current status, please refer to the Statewide Conditional Area Closure Notice on the DMR website: <https://www.maine.gov/dmr/fisheries/shellfish/closures>

CA5. Doc's Creek (Scarborough): west of a line beginning at a red painted post located on the shore of the prominent point of land at the northern mouth of Doc's Creek running southeast to the southern tip of an unnamed island, then running southwest to a red painted post at the northern point of land approximately 600 yards northeast of Pine Point Rd bridge (closed July 1st through August 31st).

Approved: All other shores, flats and waters not described in the above sections are Approved and it is lawful to dig, take or possess any clams, quahogs, oysters, mussels or whole or roe-on scallops (from aquaculture leases with an MOU only) when in the open status.
